### 1. OPEN FORUM: GUEST INTRODUCTIONS

Chair Brice asked that everyone provide a self-introduction.

## 2. STAFF PRESENTATION AND BOARD DISCUSSION: Board Workshop to Discuss District Mission, Opportunities and Long-term Sustainability Strategies.

General Manager O'Halloran reviewed the format for the meeting, noting that there would be review and discussion of the Yolo County Flood Control and Water Conservation District's (District) purpose and goals, the District's mission and vision and the priorities for 2016 activities.

O'Halloran introduced Dr. David Purkey, Stockholm Environmental Institute (SEI), to provide a PowerPoint presentation. Dr. Purkey reviewed the recently completed report on the Yolo County Flood Control and Water Conservation District Watershed Model and Decision Support Tool (Model Report) explaining the concepts, the graphs and the analyses that were incorporated into the report. The Model Report is intended to provide the District with a tool to assist in analyzing and explaining the potential impacts of various water management strategies and actions, assisting in the implementation of the Sustainable Groundwater Management Act.

The Board and staff reviewed and discussed key issues such as short-term and long-term goals, the rate setting process, irrigation and operational activities, staffing, the District's mission statement and vision, the state of the District economically and organizationally, changing regulatory requirements, and outreach activities with water customers, the public and other agencies.

There being no further business to come before the Board, the meeting was adjourned.
