1. CONSIDERATION: Approval of Minutes

M/S/C approved the minutes of the September 4, 2012 Regular Board Meeting as submitted.

2. OPEN FORUM

There were no comments.

3. CONSIDERATION: Adding Items to the Posted Agenda

There were no changes.

4. STAFF REPORT: Support Letter for Woodland-Davis Clean Water Agency Project.

General Manager O'Halloran reported that the Woodland-Davis Clean Water Agency has met with the Farm Bureau and the District staff regarding its Project and expressed the desire for a show of support for the Project from the agricultural community. O'Halloran reminded the Board that the Project represents the implementation of a project conceived by the District in 1994 when it submitted an application to appropriate 45,000 acre-feet of water for urban uses from the Sacramento River. The Project will provide direct, immediate benefits to the agricultural community near the locations where the water will be put to use by reducing the urban demand on the underlying groundwater.

O'Halloran provided a draft Letter of Support (Letter) for the Board's review and reported a list of entities to receive copies of the Letter will be added. Some editorial changes will be made to the Letter as suggested.

5. STAFF REPORT: Proposed Canal Realignment Projects.

General Manager O'Halloran reported on two potential canal realignment projects.

- a) Willow Canal – O'Halloran reviewed the project showing the current and proposed locations of a portion of the Willow Canal northeast of the City of Winters. He reported that the Board Infrastructure Committee has been briefed on the proposal. O'Halloran reviewed the proposal, meetings with the landowner, the reasons the landowner wants to move the canal at his own expense, and the benefits the new location will provide to the District. He identified a number of important issues.
 - City of Winters (City) - Close coordination will be required with the City including a letter regarding the potential impact to the City's flood control issues.
 - California Department of Fish and Game (DFG) - The Landowner is and will continue to work directly with DFG on issues related to the Moody Slough.
 - Adjacent Landowners – Landowners will share information with the adjacent landowners to ascertain any potential issues that need to be addressed.
 - Legal Agreements – The District and Landowner will need to develop legal agreements regarding the new and old canal, and comply with CEQA requirements.

- b) Moore Canal – O'Halloran reviewed a map showing a portion of the Moore Canal east of County Road 94B to State Highway 16. Teichert is a landowner and intends to mine its parcel for gravel. Teichert is interested in relocating the portion of the Moore Canal on its property to facilitate mining the area without leaving a highline canal going through it. This potential project was previously discussed with staff, but the down turn of the economy delayed further discussion. It is anticipated that the discussion will be reinitiated in the future.

6. STAFF REPORT: Summary Presentation on the District's Recently Completed AB 303 Groundwater Grant

Assistant General Manager of Resources Stevenson provided a PowerPoint Presentation reviewing the District's AB 303 grant application in 2007, approval in 2008, 2010 funding that provided \$250,000 and the actual grant work. He reported that the work has been completed and the results are reflected in four reports, which he briefly reviewed. The four reports are:

1. Drought Protection and Canal Capacity Pump Program Analysis Report (2009);
2. Using Yolo County Integrated Groundwater and Surface Water Model for Evaluation of Hydrologic Effects on Regional Surface Water Supply Project & Cache Creek Groundwater Recharge and Recovery Project (2011);
3. Enhanced Canal Recharge Feasibility Report (2012); and
4. Regional Conjunctive Use Enhancement: Nitrate Fingerprinting and Groundwater Age Determination Study (2012).

General Manager O'Halloran explained that the reports have long-term implications to the District and its water management, including conjunctive use strategies.

7. DIRECTORS' REPORTS

There were no reports.

8. ATTORNEY'S REPORT

Legal Counsel Bezerra reported on the second State Water Resources Control Board sponsored Bay-Delta workshop, which focused on the fishery resources. The Northern California Water Association and the Sacramento Area Water Forum are actively monitoring and participating in the workshops.

9. GENERAL MANAGER'S REPORT

General Manager O'Halloran reported on:

- a) General Activities
Clear Lake Hitch Issues – A document “Outline of Administrative Process Associated with the Endanger Species Act (ESA) and the Petition to List Clear Lake Hitch” was distributed. O'Halloran reported he had been in contact with Lake County staff regarding potential issues. He would like to invite Dr. Peter Moyle to make a presentation to the Board regarding the Hitch, and would like the Chair to appoint an Ad Hoc Committee to be available in the event that O'Halloran needs to get some Board input. Chair Mayer created a Clear Lake Hitch Ad Hoc Committee, to which he appointed Directors Brice and Vink.
- b) Operations, Maintenance and Water Conditions
Water Condition Reports – was provided as a handout
Current Operations - Diversions into the canals, canal sales and water losses were reviewed.
End of Releases from Storage - The proposed end of releases is October 12, 2012. Water will be sold as long as it is available within the canals.

10. GENERAL DISCUSSION

Director Rominger asked if the proposed program to address waiting list will be available next year. General Manager O'Halloran reported that the computer programming has been developed and is in the testing stages. A letter explaining the new capacity allocation policy will be mailed to water customers shortly.

Director Brice announced that November 9, 2012 was the date for the Bucks for Ducks event. The guest speaker will be Chuck Bonham, Director, California Department of Fish and Game.
