#### 1. **CONSIDERATION: Approval of Minutes**

#### 3. CONSIDERATION: Adding Items to the Posted Agenda

#### 4. CONSIDERATION: Election of Officers for 2020

General Manager O'Halloran reviewed the Board's past policy of rotating Directors through the positions of chair and vice chair. ## 5. <u>CONSIDERATION: Temporary Permit for Diversion and Use of Water for Groundwater Recharge</u>

Like the 2016, 2017, 2018, and 2019 temporary permits, the 2020 permit conditions require the District quantify groundwater extraction and use and determine that the extractions are from water stored by the District and not based on other claims of right. To facilitate compliance with the "basis of right" term, Stevenson requested the Board adopt Resolution 20.01 to authorize the District to monitor groundwater use over time to confirm the volume of surface water diverted has been extracted and applied to irrigation during the 2020 irrigation season.

## 6. <u>CONSIDERATION: Moore Siphon Failure Emergency Repair and Replacement Project Update</u>

General Manager O'Halloran and Assistant General Manager Stevenson provided an update on the status of the Moore Siphon Replacement Project. As of last month, all pipe sections have been delivered and all old pipe has been removed. Only 32 feet of pipe remain to be installed on the north side. The embankments of the creek have been reconstructed and the channel has been graded to pre-project conditions. The main remaining task, construction of the formed concrete inlet structure has been delayed due to inclement weather.

District staff recommended the Board declare continuation of the emergency conditions related to the Moore Siphon Failure Repair and Replacement Project.

#### **BACKGROUND:**

In 1982, the District in conjunction with the County of Yolo (County), the City of Davis (City) and the developer Frank Liggett relocated the Covell Ditch (Ditch) from the median strip of Covell Boulevard in Davis to the northern edge of the City between Highway 113 and CR 101A/F Street. The County was involved because the project included an annexation into the City from the County. Initially it was planned that the District would utilize the Ditch to move irrigation water from the west side of the City to agricultural lands on the east side. The easements were granted to the District with the City having the maintenance responsibilities until such time as the District began to use the Ditch for irrigation purposes.

Since the District owns the easement for the Ditch, potential changes to the Ditch require District approval. The City has the operations and maintenance obligations, but it still must coordinate with the District in the event it wants to make changes to the Ditch. For example, the Ditch was rerouted at F Street, drainage culverts have been added, and the Putah Creek Council planted native trees and shrubs to facilitate educational opportunities within the Ditch.

The District will not be utilizing the Ditch for irrigation purposes. The only other interest that the District may have in the Ditch would be related to drainage issues. The City maintains not only the Ditch, but also the downstream Channel A, as shown as Exhibit A of the quit claim deed, to and including the pump station at the Willow Slough Bypass. If it were not for

the ownership of the easement, there would be no reason for the District to be involved with activities related to the Ditch.

Attached is a December 17, 2019 letter from the Dianna Jensen, Davis City Engineer, requesting the District quit claim the Ditch to the City. In order to do that, the Board must declare the Covell Ditch to be Surplus Property by resolution and authorize execution of a quit claim providing the Covell Ditch to the City of Davis.

#### RECOMMENDATION

Staff recommends that the Board adopt Resolution 20.02 Declaring the Covell Ditch Surplus to the Needs of the District and authorize execution of a quit claim of the Covell Ditch to the City of Davis.

# A RESOLUTION OF THE BOARD OF DIRECTORS OF THE YOLO COUNTY FLOOD CONTROL AND WATER CONSERVATION DISTRICT DECLARING THE COVELL DITCH AS SURPLUS REAL PROPERTY AND AUTHORIZING QUIT CLAIM TO THE CITY OF DAVIS

WHEREAS, in 1982, the Yolo County Flood Control and Water Conservation District ("District") in conjunction with the County of Yolo (County) and the City of Davis (City) relocated a drainage ditch along Covell Street, to the North edge of Davis, the Covell Ditch (Ditch); and

**WHEREAS**, the County's involvement was simply to approve a necessary annexation of land to the City; and

**WHEREAS**, the District's involvement was to hold the easements to facilitate the future use of the Ditch, if it became feasible, to move irrigation water through it to lands east of Davis; and

**WHEREAS**, the City is responsible for the operation and maintenance of the Ditch requiring coordination with the District to utilize the Ditch for irrigation purposes; and

WHEREAS, the District no longer intends to utilize the Ditch for irrigation purposes; and

**WHEREAS,** the City has requested that the District quit claim the Ditch to the City; and

WHEREAS, in accordance with Section 65-9 of the Yolo County Flood Control and Water Conservation District Act (Water Code Appendix Section 65-9) the District's Board of Directors may authorize the sale or disposal of any interest in real and personal property that is no longer necessary to be retained for the District's uses and purposes.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Directors of the Yolo County Flood Control and Water Conservation District declares the Covell Ditch and all District asset within and along the Covell Ditch starting at Highway 113 east to Channel A, including two F Street crossings to be surplus to the needs to the District; and

**BE IT FURTHER RESOLVED** that the Board of Directors authorizes the General Manager or his designee to negotiate with the City of Davis and to tale all actions necessary to quit claim the properties hereby declared surplus to the City of Davis.

#### **BACKGROUND:**

On May 30, 2019, a rupture was discovered in the District's Moore Siphon causing water deliveries to cease to the Moore System – the Alder, Moore, Maple, Ross, and South Fork Canals. District staff notified all water customers of the disruption in service and immediately began working to determine the scope of the problem and to identify an interim patch repair and a long-term solution. General Manager O'Halloran declared an emergency on May 30, 2019, and District staff notified state and federal agencies of the emergency activities for permitting the repair and replacement of the siphon.

Staff will provide an update on general replacement activities related to the Moore Siphon.

#### **RECOMMENDATION:**

District staff recommends the Board declare continuation of the emergency conditions related to the Moore Siphon Failure Emergency Repair and Replacement Project.
